Vendors will not be allowed to set up or operate if all requirements are not met and are subject to inspection by local fire department officials. **Application and food items sold are subject to approval.**

Further, said coverage must be for a limit of at least \$1,000,000.00. All of the above coverages shall remain in effect at all times during the term of this Agreement.

Vendors MUST provide a Certificate of Insurance naming the **TOWN OF SCHERERVILLE, THE SCHERERVILLE PARKS AND RECREATION BOARD OF DIRECTORS AND ITS DULY AUTHORIZED AGENTS AND EMPLOYEES** as the certificate holder and additional insured PLUS your permit from the Health Department one month prior to the event. VERY IMPORTANT to be worded exactly like that!

Further, the Vendor shall hold harmless and indemnify the Schererville Chamber of Commerce, Town of Schererville and the Schererville Parks and Recreation Board, and all authorized agents and employees from any and all liability and or claims due to COVID-19, use or consumption of the Vendor's products, or due to damage and or theft of Vendor's vehicles, equipment, merchandise, goods, and ware kept upon premises in conjunction with the event.

The Vendor understands that exclusivity on products for sale and location of set up is not guaranteed.
